Design, Development, Re-engineer and Implementation of Organizational Process Automation Platform

Geological Survey and Mines Bureau (GSMB) is a successor to the Geological Survey Department, established under the Mines and Minerals Act No 33 of 1992. The mission of the GSMB is to provide Geo-Scientific information, advice and services to the policy makers and the community and to promote and manage the mineral resources of the country for economic development while ensuring environmental sustainability. It regulates exploration, extraction, processing, value addition, transportation, trading, export and import of minerals.

GSMB has carried out a Government Process Re-engineering (GPR) study which was focused on the current processes, IT structure and regulatory structure in order to identify the gaps and opportunities for improvements. The detailed analysis was mainly concentrated on improving the efficiency in the processes of GSMB and to provide a valuable service to the clients. As a part of the GPR implementation, GSMB envisions to implement an Organizational Process Automation Platform with the use of Information Technology which will involve the development and integration of several software solutions to support the organizational processes. This solution platform will include the Design, Development, Implementation and Integration of the systems for License Issuance, Project Management & Monitoring, Finance and GIS. In this light, GSMB has decided to engage a Software Development Service Provider to develop and implement this solution.

GSMB now invites Expression of Interest (EOI) from interested Software Service Providers to take up this assignment. EOI must include requested information as specified in the EOI Information Form along with documentary evidence in support of the core business and years in business, financial/business and administrative strength, qualifications in the field of assignment, experience in carrying out assignments of a similar nature and complexity, technical and managerial organization of the firm, technical capabilities and appropriate skills of the key staff of the organization and other relevant information. Service provider may also associate to enhance the qualifications.
